Keiser University received education stabilization funds under the ARP (a)(1) and (a)(4). Keiser University has adopted a flexible approach to administering emergency grants to students negatively impacted by the COVID-19 economic crisis. In creating this policy, the University seeks to achieve five goals:

• To expeditiously develop and implement a plan to distribute CARES Act funds to Keiser University Students.

- To adhere to CARES Act requirements and Department of Education interpretive guidance in distributing funds.
- To create a process for awarding of funds that is defensible, replicable, and equitable a process which will stand up to predictable future scrutiny (auditors, legislators, media, etc.).
- To distribute funds in a manner that best ensures student support in light of COVID-19 and economic challenges.
- To utilize existing processes and automate the awarding, distribution, and tracking process to the greatest degree possible.

- Enrolled with an active status with attendance posted on or after 5/15/2021 or;
- Enrolled with an LOA, AI, SG status as of 5/15/2021
- Citizenship status either US Citizen or Eligible Non-Citizen
- Military students were awarded the maximum Full-time or Part-time award amount based on their schedule status as of 5/15/2021
- Online students are eligible
- Must have a FAFSA on file with a valid EFC

Flagship and San Marcos students received their awards following the Fall start to determine student eligibility for the Fall 2021 semester. \$1,733,591 in HEERF III was reserved for these students, but fewer than expected returned, thus the distribution amount per student was adjusted to utilize the remaining HEERF III funds for this final distribution.
