The Office of the Public Defender was established in the 1960's and I have been the elected Public Defender in Hillsborough County since 1993. There are twenty elected Public Defenders across the State of Florida, representing the twenty Judicial Circuits in the State. Our office represents indigent criminal defendant's accused of crimes in Hillsborough County. Our office employs staff in a range of positions that each contribute to the representation of defendant's charged with crimes from misdemeanors through capital crimes such as homicide. We employee data entry staff, legal assistants, social services staff, investigators, administrators, and attorneys.

Having staff with higher education at all levels enhances the quality of representation that our clients receive. In the case of attorneys, a quality education before law school is important to their success in law school and beyond.
